

"ENVIRONMENTAL PERMITTING REGULATIONS

PART 1

GRANT OF LANDFILL PERMITS

Application of Part

- 1 (1) This Part applies where
 - (a) an application is made under the Environmental Permitting Regulations for the grant of an environmental permit authorising the operation of a regulated facility that includes a landfill, and
 - (b) the landfill is, or is to be, located on land within—
 - (i) the Act limits, or
 - (ii) a zone specified by a relevant safeguarding direction.
 - (2) In sub-paragraph (1) "relevant safeguarding direction" means a direction made under article 31(1) of the Town and Country Planning (Development Management Procedure) (England) Order 2015 (S.I. 2015/595) restricting the grant of permission by a local planning authority in respect of development within sub-paragraph (3).
 - (3) Development is within this sub-paragraph if it may conflict with the construction of the high speed railway transport network referred to in section 1(1) of the High Speed Rail (Preparation) Act 2013.

Modification of Environmental Permitting Regulations

The Environmental Permitting Regulations have effect in relation to the application as if in Part 1 of Schedule 5 (environmental permits), after paragraph 12 there were inserted—

"12A Determination of certain landfill-related applications

- (1) Where Part 1 of Schedule (*Environmental Permitting Regulations*) to the High Speed Rail (Crewe Manchester) Act 2023 applies in relation to an application for the grant of an environmental permit authorising the operation of a regulated facility that includes a landfill, the application must include a certificate within sub-paragraph (4).
- (2) If the application does not include such a certificate—
 - (a) the application is not to be treated as having been duly-made (and accordingly paragraph 12(1) of this Part (duty to determine application) does not apply in relation to the application), and
 - (b) the regulator must notify the applicant that the application has not been duly-made.
- (3) A notification under sub-paragraph (2)(b) is not a decision to refuse the application (and accordingly no right of appeal under regulation 31(1) (appeals to an appropriate authority) arises).
- (4) A certificate is within this sub-paragraph if it—
 - (a) is issued by the Secretary of State, and
 - (b) indicates that the Secretary of State considers that the operation of the regulated facility could not interfere with (as the case may be)—
 - (i) the use of the relevant land for Phase 2b (Crewe Manchester) purposes, or
 - (ii) the construction of the high speed railway transport network referred to in section 1(1) of the High Speed Rail

(Preparation) Act 2013.

(5) In sub-paragraph (4)—

- "Phase 2b (Crewe Manchester) purposes" is to be construed in accordance with section 62 of the High Speed Rail (Crewe Manchester) Act 2023;
- "relevant land" means the land mentioned in paragraph 1(1)(b) of Schedule (*Environmental Permitting Regulations*) to that Act."

PART 2

SURRENDER OF LANDFILL PERMITS

Application of Part

- 3 (1) This Part applies where—
 - (a) the Secretary of State acquires or proposes to acquire land within the Act limits for Phase 2b (Crewe Manchester) purposes, and
 - (b) the land consists of or includes a site or part of a site in relation to which a relevant landfill environmental permit has effect.
 - (2) In this Part—
 - (a) "relevant landfill environmental permit" means an environmental permit authorising the operation of a regulated facility that includes a landfill that accepts only inert waste;
 - (b) "inert waste" has the meaning given in Article 2(e) of the Landfill Directive.

Liability

- 4 (1) Sub-paragraphs (2) and (3) apply where—
 - (a) the Secretary of State acquires land as mentioned in paragraph 3(1), or
 - (b) following such an acquisition, the nominated undertaker surrenders a relevant landfill environmental permit in relation to the land in accordance with the Environmental Permitting Regulations (as they have effect in accordance with this Part).
 - (2) The acquisition or surrender does not affect any liability or obligation of the operator of the regulated facility arising under or by virtue of the Environmental Permitting Regulations in respect of anything done or omitted to be done by the operator in relation to the regulated facility before the acquisition or surrender.
 - (3) The acquisition or surrender does not impose any liability or obligation on the Secretary of State or the nominated undertaker under or by virtue of those regulations in respect of anything done or omitted to be done by the operator in relation to the regulated facility before the acquisition or surrender.
 - (4) In this paragraph, a reference to the regulated facility is a reference to the regulated facility mentioned in paragraph 3.

Modification of Environmental Permitting Regulations

5 The Environmental Permitting Regulations have effect in relation to a relevant landfill environmental permit as if they were subject to the modifications set out in

paragraphs 6 and 7.

In regulation 2 (interpretation), in paragraph (1), at the appropriate places insert—

""nominated undertaker" has the same meaning as in the High Speed
Rail (Crewe - Manchester) Act 2023;";

""relevant landfill environmental permit" has the same meaning as in Part 2 of Schedule (*Environmental Permitting Regulations*) to the High Speed Rail (Crewe - Manchester) Act 2023;".

- 7 In regulation 25 (application for the surrender of an environmental permit), for paragraph (2) substitute—
 - "(2) By application to the regulator—
 - (a) an operator may surrender an environmental permit, or that part of a permit, to which this regulation applies, and
 - (b) the nominated undertaker may surrender a relevant landfill environmental permit, or that part of such a permit, to which this regulation applies.
 - (2A) But paragraph (2)(b) applies only where the application relates to a site or part of a site which has been acquired by the Secretary of State as mentioned in paragraph 3 of Schedule (*Environmental Permitting Regulations*) to the High Speed Rail (Crewe Manchester) Act 2023."
- 8 (1) Part 1 of Schedule 5 (environmental permits) to the Environmental Permitting Regulations has effect in relation to a relevant landfill environmental permit as if that Part were subject to the following modifications.
 - (2) In paragraph 1 (interpretation), in the definition of "applicant", after paragraph (a) insert—
 - "(aa) in the case of an application for the surrender, in whole orin part, of a relevant landfill environmental permit, the operator or the nominated undertaker;".
 - (3) In paragraph 4 (further information in respect of a duly-made application), after sub-paragraph (3) insert—
 - "(4) Sub-paragraphs (1) to (3) do not apply to a duly-made application made by the nominated undertaker for the surrender of a relevant landfill environmental permit in whole or in part.
 - (5) If the regulator considers that it requires further information to determine such an application, it may serve a notice on the nominated undertaker specifying the further information and the period within which it must be provided."
 - (4) After paragraph 4 insert—

"4A Provision of information to the nominated undertaker

- (1) This paragraph applies where the nominated undertaker makes or intends to make an application under regulation 25(2)(b) for the surrender in whole or in part of a relevant landfill environmental permit.
- (2) If the nominated undertaker requires information from the operator in order to comply with paragraph 2 (making an application) or 4 (further information) of this Part, the nominated undertaker may serve a notice on the operator specifying the information and the period within which it must be provided to the nominated undertaker.

- (3) The nominated undertaker may take proceedings in the High Court for the purpose of securing compliance with a notice under sub-paragraph(2) requiring the provision of information (whether or not the nominated undertaker has taken other steps for that purpose)."
- (5) In paragraph 14 (surrender applications)—
 - (a) in sub-paragraph (1), for paragraph (b) substitute—
 - "(b) to return the site of the regulated facility to a satisfactory state, having regard to—
 - (i) in the case of an application under regulation 25(2)(a), the state of the site before the facility was put into operation, or
 - (ii) in the case of an application under regulation 25(2)(b), the use of the site for Phase 2b (Crewe Manchester) purposes.";
 - (b) after sub-paragraph (3) insert—
 - "(4) In this paragraph "Phase 2b (Crewe Manchester) purposes" is to be construed in accordance with section 62 of the High Speed Rail (Crewe Manchester) Act 2023."

PART 3
