## Member's explanatory statement

  - "(9) A decision under subsection (2) may include a decision by a university or research institution based in the United Kingdom to enter into a commercial partnership with another university or research institution in a foreign state."

#### LORD MANN

- 9★ Clause 1, page 1, line 23, at end insert
  - "(9) A decision under subsection (2) may include a decision by a public body relating to the procurement of food prepared in line with religious practices, such as kosher or halal food."

## LORD WALLACE OF SALTAIRE

10 Clause 2, page 2, line 3, leave out from "decision-maker" to end of line 4 and insert "is acting on behalf of a public body."

#### *Member's explanatory statement*

*This, alongside another to Clause 2 in the name of Lord Wallace of Saltaire, is a probing amendment to clarify the distinction between a public body and a public authority.* 

## **BARONESS NOAKES**

11 Clause 2, page 2, line 3, leave out "subject to section 6 of the Human Rights Act 1998 (acts of public authorities)" and insert "a public authority for the purposes of the Freedom of Information Act 2000"

#### Member's explanatory statement

This amendment provides an alternative definition of the public bodies covered by the Bill.

#### BARONESS NOAKES

12 Clause 2, page 2, line 4, at end insert "but it does not apply if the decision-maker is a public authority only by virtue of subsection (3)(b) of that section"

## Member's explanatory statement

*This amendment probes the extent to which the Bill applies to bodies which are not public sector bodies.* 

## LORD WALLACE OF SALTAIRE

13 Clause 2, page 2, line 4, at end insert –

"(1A) For the purpose of this section a public body is defined as one which receives 50 per cent or more of its funding from government, and whose functions are clearly of an official nature."

### Member's explanatory statement

This, alongside another to Clause 2 in the name of Lord Wallace of Saltaire, is a probing amendment to clarify the distinction between a public body and a public authority.

## LORD COLLINS OF HIGHBURY BARONESS CHAPMAN OF DARLINGTON LORD WALLACE OF SALTAIRE

14★ Clause 2, page 2, line 4, at end insert –

- "(1A) For the purpose of this section an act of a public authority does not include a private function or act of a hybrid authority.
- (1B) In this section, "hybrid authority" means a private body which is a public authority by virtue of the fact they are performing a public function."

## Member's explanatory statement

This is to probe further details about the statement in the explanatory notes to this clause that "Any 'hybrid' public authorities (private bodies which are public authorities by virtue of the fact they are performing a public function) will not be in scope of the bill in relation to their private functions and acts."

## LORD HAIN

- 15★ Clause 3, page 2, line 24, at end insert
  - "(2A) Regulations under subsection (2) may not amend the Schedule to remove environmental misconduct as an exception from the application of section 1."

## Member's explanatory statement

This amendment seeks to ensure that the Secretary of State cannot remove environmental misconduct as an exception in the Schedule by regulations.

Clause 3, page 2, line 28, leave out paragraphs (b) to (d)

This amendment and others are consequential to another in the name of Baroness Bryan of Partick to Clause 17, removing Wales, Scotland and Northern Ireland from the territorial application of the Bill.

## BARONESS BRYAN OF PARTICK BARONESS RITCHIE OF DOWNPATRICK LORD HAIN LORD THOMAS OF CWMGIEDD

17 Clause 3, page 2, line 34, leave out paragraph (f)

## Member's explanatory statement

This amendment and others are consequential to another in the name of Baroness Bryan of Partick to Clause 17, removing Wales, Scotland and Northern Ireland from the territorial application of the Bill.

## LORD VERDIRAME LORD ETHERTON

- 18 Clause 3, page 2, line 36, at end insert
  - "(3A) Regulations under subsection (2)(b) may include descriptions of considerations (including disregard thereof) to give effect to the United Kingdom's obligations under international law."

## Member's explanatory statement

*This amendment seeks to provide for a clearer way of implementing the international law exception in paragraph 6 of Part 2 of the Schedule.* 

## LORD COLLINS OF HIGHBURY LORD HAIN LORD WARNER

Clause 3, page 2, line 40, at end insert –

- "(4A) Section 1 does not apply to a decision which has been made in accordance with a Statement of Policy Relating to Human Rights.
- (4B) A "Statement of Policy Relating to Human Rights" -
  - (a) is a public authority's policy criteria relating to disinvestment in cases concerning contravention of human rights, and
  - (b) must be applied consistently by the public authority to all foreign countries.
- (4C) Within 60 days of the passing of this Act, the Secretary of State must publish, and lay before Parliament, guidance on the form, content and application of a Statement for the purposes of this section.

(4D) Public authorities must have regard to the guidance referenced in subsection (4C) when devising a Statement for the purposes of this section."

## Member's explanatory statement

This amendment would exempt public bodies from the prohibition in section 1 where the decision has been made in accordance with a Statement of Policy Relating to Human Rights. A Statement may not single out individual nations – the policy would have to be applied consistently, and in accordance with guidance published by the Secretary of State.

"3A Section 1 does not apply to –

- (a) a registered higher education provider in England, as defined by section 3(10) of the Higher Education and Research Act 2017;
- (b) an institution within the higher education sector in Wales, as defined by section 91 of the Further and Higher Education Act 1992;
- (c) an institution within the higher education sector in Scotland, as defined by section 56 of the Further and Higher Education (Scotland) Act 1992;

#### Member's explanatory statement

*This amendment would remove universities and other higher education providers from the requirement to act in accordance with Clause 1.*

  - "3A Section 1 does not apply to
    - (a) a school, as defined by section 4 of the Education Act 1996;
    - (b) an early years provider, as defined by Part 3 of the Childcare Act 2006."

This probes whether a school or nursery would come under the scope of the bill.

## LORD COLLINS OF HIGHBURY BARONESS CHAPMAN OF DARLINGTON

**23★** The Schedule, page 12, line 21, at end insert –

"3A Section 1 does not apply to a body providing a public function where that body is a charity as defined by section 1 of the Charities Act 2011."

## Member's explanatory statement

This probes whether a charity which is delivering a public function - this may include, for example, a charity contracted by a local authority to provide a refuge service - would come under the scope of the bill.

## LORD COLLINS OF HIGHBURY BARONESS CHAPMAN OF DARLINGTON

- 24★ The Schedule, page 12, line 21, at end insert
  - "3A Section 1 does not apply to a body providing a public function where that body is a community interest company."

#### Member's explanatory statement

This probes whether a community interest company which is delivering a public function would come under the scope of the bill.

## LORD COLLINS OF HIGHBURY BARONESS CHAPMAN OF DARLINGTON

- 25★ The Schedule, page 12, line 21, at end insert
  - "3A Section 1 does not apply to national governing bodies of sports, whether or not they are in receipt of public funding."

## Member's explanatory statement

This probes whether a national governing body of sport (NGB) which is receipt of public funding would be covered in any part by this bill.

## LORD COLLINS OF HIGHBURY BARONESS CHAPMAN OF DARLINGTON

26★ The Schedule, page 12, line 21, at end insert –

"3A Section 1 does not apply to a body providing a public function where that body is a charity as defined by section 1 of the Charities Act 2011, and it is primarily focused on delivering humanitarian projects, services or aid in a foreign territory."

## Member's explanatory statement

This probes whether charitable organisations which are delivering public functions and are primarily focused on overseas activities and humanitarian aid - so by their nature are making regular decisions based on territorial considerations - would come under the scope of the bill.

27★ The Schedule, page 12, line 26, after "financial", insert "risk, impact and"

## Member's explanatory statement

This amendment seeks to allow decision-makers in public bodies to consider the financial risk and impact associated with, for example, the delivery of contracted goods and services and the investments in the Local Government Pension Scheme, without falling foul of the prohibition.

**28** The Schedule, page 13, line 2, leave out paragraph 6

## Member's explanatory statement

*This amendment probes the scope of paragraph 6 and its intended purpose.* 

## LORD VERDIRAME LORD ETHERTON

**29** The Schedule, page 13, line 2, leave out from "consideration" to end of line 5 and insert "if so required by a regulation adopted under section 3(2)(b) to give effect to the United Kingdom's obligations under international law."

*Member's explanatory statement This amendment is consequential to the amendment to Clause 3.* 

## BARONESS BLOWER

30★ The Schedule, page 13, line 5, at end insert "and conventions, including the Genocide Convention, the Universal Declaration on Human Rights or any United Nations Security Council Resolution supported by the United Kingdom."

#### LORD HENDY BARONESS BLOWER

31 The Schedule, page 13, line 5, at end insert –

"6A Section 1 does not prevent regard to a consideration so far as the decision-maker reasonably considers it relevant to whether the goods, services or works subject to a procurement decision or their manufacture, provision or supply to the decision maker would or might involve a breach of international law."

#### Member's explanatory statement

This amendment would extend consideration of breach of international law from breaches by the UK to breaches by territories outside the UK in the manufacture, provision or supply of goods, services or works.

  - (ii) the elimination of all forms of forced or compulsory labour,
  - (iii) the effective abolition of child labour,
  - (iv) the elimination of discrimination in respect of employment and occupation,
  - (v) decent working conditions for all, with regard to, inter alia, wages and earnings, working hours, maternity leave and other conditions of work,
  - (vi) health and safety at work, including the prevention of occupational injury or illness and compensation in cases of such injury or illness, and
  - (vii) non-discrimination in respect of working conditions, including for migrant workers."

## Member's explanatory statement

This amendment would allow a public body, when taking procurement decisions (as defined in section 2(2)), to consider violations or potential violations of International Labour Organization fundamental labour standards (all of which the UK has ratified). The wording is drawn from Article 399(2) and (6) of the Trade and Cooperation Agreement of 2020 (the "Brexit Deal") agreed by HM Government.

#### *Member's explanatory statement*

This amendment would remove management from the definition of a fund investment decision, to allow investors to carry out stewardship activities include engagement and voting, without falling foul of the prohibition.

After Clause 15, insert the following new Clause -

## "Review of this Act's compliance with the Human Rights Act 1998

- (1)The Secretary of State must, within 6 months of the passing of this Act, lay before Parliament a review of the Act's compliance with the obligations under the Human Rights Act 1998.
- The review under subsection (1) must, in particular, assess the Act's interaction (2)with the right to freedom of expression under Article 10 of the European Convention on Human Rights."

## Member's explanatory statement

This amendment aims to probe to extent to which the Bill is compliant with Article 10 of the ECHR and, if not, whether it is then non-compliant with section 6 of the Human Rights Act 1998.

- (2) The Secretary of State or the Minister for the Cabinet Office must produce a report on the outcome of the impact assessment.
- (3) The report mentioned in subsection (2) must be laid before Parliament as soon as reasonably practicable after the impact assessment has been conducted."

This new Clause would require the Government to undertake an assessment of the impact of the Act on the UK's trade and diplomatic relations with the countries identified by the FCDO as human rights priority countries.

This amendment to Clause 17, removes Wales, Scotland and Northern Ireland from the territorial application of the Bill.

## BARONESS CHAPMAN OF DARLINGTON

Clause 17, page 10, line 39, at end insert –

- "(1A) Section 1 does not apply to decisions made by
  - (a) Scottish Ministers, unless a motion has been passed by the Scottish Parliament indicating its consent to this Act;
  - (b) Welsh Ministers, unless a motion has been passed by Senedd Cymru indicating its consent to this Act;
  - (c) a Northern Ireland department, unless a motion has been passed by the Northern Ireland Assembly indicating its consent to this Act."

#### Member's explanatory statement

This would provide that the Act does not apply to decisions made by Scottish Ministers, Welsh Ministers or a Northern Ireland department unless an appropriate legislative consent motion has been passed.

52 Clause 17, page 11, line 1, leave out "13(2) and (3) and"

#### Member's explanatory statement

*This amendment is consequential on the amendment to Clause 17, page 10, line 38 in the name of Baroness Bryan of Partick.* 

## LORD WARNER

53 Clause 17, page 11, line 3, leave out subsection (3) and insert –

"(3A) This section comes into force on the day on which this Act is passed.

(3B) The rest of this Act may not come into force until before 31 January 2025 or until the Secretary of State has laid a statement before Parliament explaining how the Act furthers the foreign policy objectives of the United Kingdom in relation to the Occupied Palestinian Territories and Gaza."

This would require the Secretary of State to provide a comprehensive list of which bodies come into scope of this bill, before the provisions in Clause 1 can be brought into force.

  - "(4A) The Secretary of State may not lay regulations to bring section 1 into force until the Secretary of State has published guidance on in what circumstances an individual is considered to be a "decision-maker" for the purposes of that section, and laid it before Parliament."

## Member's explanatory statement

This would require the Secretary of State to publish guidance to clarify in what circumstances an individual is "a decision-maker" for the purposes of this bill.
