This amendment is consequential on my other amendment to this Clause.

#### Member's explanatory statement

This amendment ensures that, where a person was charged with an offence allegedly committed over a period of time as mentioned in Clause 2(2)(b), it is not necessary for the Horizon system to have been used for the purposes of the post office business in question for the whole of that period: for example, where the period in question straddles the date of the replacement of the Horizon system.

14★ After Clause 6 insert the following new Clause –

#### "Statements on predecessor software programmes or systems

- (1) Where a formal investigation or inquiry concludes that a predecessor software programme used by the Post Office had flaws that may have led to convictions of sub postmasters, the Secretary of State must make a Statement before the House of Commons.
- (2) The Statement in subsection (1) must outline what action the Government will take to ensure those convictions will be subject to a similar process to that outlined in this Act."

#### Member's explanatory statement

This is a probing amendment for the Minister to explain what actions will be taken should Capture (or any other predecessor computer programme to Horizon) be found, following a formal investigation, to have resulted in post office staff being wrongly convicted.

16 After Clause 9, insert the following new Clause –

#### "Equivalent provisions in Scotland

Within three months of the day on which this Act is passed, the Secretary of State must lay before Parliament a review of the case for applying the provisions of this Act in Scotland."

#### LORD HOLMES OF RICHMOND

17 After Clause 9, insert the following new Clause –

#### "Review of power to bring prosecutions

- (1) The Secretary of State must, within six months of the passing of this Act, lay before Parliament a report on the power to bring prosecutions under section 6 of the Prosecution of Offences Act 1985.
- (2) The report must, among other things, cover
  - (a) the role of section 6 in the convictions which are quashed under this Act, and
  - (b) whether additional safeguards, such as reporting requirements on the use of such prosecutions, are needed."

#### LORD HOLMES OF RICHMOND

18 After Clause 9, insert the following new Clause –

#### "Review of admissibility of computer evidence

- (1) The Secretary of State must, within six months of this passing of this Act, lay before Parliament a review of the role of computer evidence in the convictions quashed under this Act.
- (2) The review under subsection (1) may include recommendations to address any issues identified by the review in relation to standards of computer evidence used in court proceedings."

#### LORD HOLMES OF RICHMOND

19 After Clause 9, insert the following new Clause –

## "Review of role of Post Office governance model in the convictions quashed under this Act

- (1) The Secretary of State must, within one year of the passing of this Act, lay before Parliament a report following a review of the role of the Governance model of the Post Office in the convictions quashed under this Act.
- (2) The review must be conducted by a group of no less than 30 individuals with recent and relevant experience in the Post Office and 66% of the membership must be made up of post mistresses and post masters, including the Chair."
