Member's explanatory statement

No Learning Centre should be constructed underground in order that a Learning Centre be constructed of adequate size in line with the recommendation of the 2015 Prime Minister's Holocaust Commission Report and in order to avoid detriment to Victoria Tower Gardens

After Clause 2, insert the following new Clause—

“Report: effects of the construction, presence and use of the Holocaust Memorial and Learning Centre on the security of the site and surrounding area

- (1) Within three months of the day on which this Act is passed, the Secretary of State must lay a report before Parliament setting out the predicted effects on the security of the site and surrounding area arising from the construction, presence and use of any Holocaust Memorial and Learning Centre in Victoria Tower Gardens.
- (2) The report under subsection (1) must include—
 - (a) a list of those bodies and individuals consulted before construction of a Holocaust Memorial and Learning Centre (subject to redaction of names where necessitated by national security),
 - (b) a summary of the advice provided by each body and individual consulted,
 - (c) a full description with visual depictions of all road and traffic changes, at and near to the chosen site, proposed to be made during construction and following completion of the Holocaust Memorial and Learning Centre,
 - (d) proposals for the continuing assessment of the security of the site and nearby buildings, and
 - (e) such other security information as the Secretary of State considers to be relevant.
- (3) The Secretary of State may delegate the preparation of the report referred to in subsection (1) to the Independent Reviewer of Terrorism Legislation.
- (4) The Secretary of State must arrange for the tabling of a motion for resolution in each House of Parliament within 56 days of laying the report before Parliament.”

“Learning Centre purpose

The sole purpose of any Learning Centre must be the provision of education about the genocide of the Jews and antisemitism.”

After Clause 2, insert the following new Clause —

“Any new planning application to consider better alternatives

The Secretary of State must ensure that any future planning process relating to the expenditure specified in section 1(a) must take into account at least two alternative proposals for each construction specified in section 1(a)(i) and section 1(a)(ii).”

Member's explanatory statement

This amendment seeks to ensure that attention is given to alternative sites in order to reduce any security risks, to enable the inclusion of the Learning Centre within a new Jewish museum and to seek an alternative to the proposed design of the Holocaust Memorial.

After Clause 2, insert the following new Clause —

“Planning application and report to Parliament

- (1) In the event of any planning consent being granted for a Holocaust Memorial and Learning Centre, the Secretary of State must arrange for the tabling of a motion for resolution in each House of Parliament on that planning consent within 60 days of that consent being granted.
- (2) Construction of a Holocaust Memorial and Learning Centre must not begin until planning consent has been approved by both Houses of Parliament, in the form of a motion for resolution under subsection (1).”

Member's explanatory statement

This Clause seeks to ensure Parliamentary approval of the size and design of any Holocaust Memorial and Learning Centre in addition to planning consent, and to allow Parliamentary consideration of the implications of planning consent for Restoration and Renewal of the Palace of Westminster.

“Resolution before implementation of planning permission

No implementation of any planning permission for a Holocaust Memorial and Learning Centre in Victoria Tower Gardens shall take place without a resolution of each House of Parliament made after the final planning permission determination.”

“Matters to be taken into account in determining planning application

Any determination involving consideration of any application to grant planning permission for any Holocaust Memorial and Learning Centre in Victoria Tower Gardens must take into account all relevant matters at the time of the determination.”

“Restoration and Renewal of Parliament not to be impeded

The activities described in section 1(1) may not be commenced on the land referred to in section 2 unless the authorities of both Houses of Parliament have certified that they are satisfied that those activities will not impede the approval and implementation of any restoration and renewal of the Palace of Westminster.”

Member's explanatory statement

This Clause seeks to ensure that any Holocaust Memorial and/or Learning Centre in Victoria Tower Gardens has no adverse effect on the Restoration and Renewal of the Palace of Westminster including the planning consent for this project and the consequent disapplication of the London County Council (Improvements) Act 1900.

- (2A) Other sections in this Act come into force on the day the report required by section (*Report: effects of the construction, presence and use of the Holocaust Memorial and Learning Centre on the security of the site and surrounding area*) has been approved by both Houses of Parliament, in the form of a motion for resolution under section (*Report: effects of the construction, presence and use of the Holocaust Memorial and Learning Centre on the security of the site and surrounding area*)(4).”

- (a) the integrity, authenticity, or outstanding universal value of the Palace of Westminster and Westminster Abbey including Saint Margaret's Church World Heritage Site;
- (b) any other memorial or the setting of such memorials in Victoria Tower Gardens;
- (c) the integrity of the Victoria Tower Gardens as a green space dedicated to the wellbeing of local people, in perpetuity."

Member's explanatory statement

This new Clause seeks to obtain the approval of heritage bodies which have expressed grave concern about the planned use of Victoria Tower Gardens; and to protect the Spicer and Buxton Memorials in Victoria Tower Gardens.
